三分二學生可回校上課

育局昨日宣布放寬復活

節假期後面授課堂安排,所有幼稚園、中小學及提供非正規 課程的私立學校,可安排最多三分之二學生回校上課,課堂 時間仍以半天為限。教育局將於下星期發信學校通知相關細 節安排,教育界對此均表示歡迎。

上課時間暫仍限半天

教育局昨日宣布,考慮疫情最新發展、衛生專家的 意見及學校準備情況後,決定所有幼稚園、中小學及 提供非正規課程的私立學校在學校復活節假期後,按 學校需要安排更多學生回校,並增至以不多於全校人 數三分之二爲限,上課時間仍以半天爲限

授課時間安排方面,中學可安排個別年級的學生於 上午或下午回校進行不多於半天的面授課堂,而學校 不可安排同一級別學生進行全日課堂,避免學生出外 用膳。小學可安排個別級別的學生於上午回校進行不 多於半天的面授課堂。上午班或下午班的幼稚園可安 排個別年級的學童分別於上午或下午回校進行半天課 堂,而全日班的幼稚園可安排個別年級的學童於上午 或下午回校進行不多於半天的面授課堂

教聯促增設更多接種點

教育局提醒學校,在全校未恢復面授課堂和校內活 動之前,應採取適當的預防措施及相應安排,彈性運 用不同的教學模式教學,讓學 生持續在家學習。在這期間, 學校須如常保持校舍開放,讓 家中缺乏人照顧的學生回校

教育界對此表示歡迎,教聯會表示,過去一年學校 暫停面授課堂多時,學生在學習及社交方面受到不少 影響,學校及家長都迫切期望能夠盡快恢復面授課 堂,讓學生重投校園生活。當疫情進一步穩定時,教 聯會呼籲當局考慮全港學校恢復面授課堂,同時盡快 與內地當局商討,協助安排跨境生分階段回港上課。 教聯會亦促請當局推出措施,方便教職員定期接受病 毒檢測,包括增加樣本收發地點,並期望當局安排醫 護人員到校爲教職員進行疫苗接種,或在每區增設更

資助小學校長會名譽主席張勇邦表示,除高年級 外,學校會安排一年級學生恢復面授課堂,他們升上 小學後沒有太多上課機會,讓他們回到校園有助盡快 適應小學生活。他認為,在6年級學生完成呈分試及 升中選校程序後,可先暫停面授課堂,讓其他年級輪 流回校。他希望當局放寬非接觸式運動的限制,讓學 校能安排學生在下午時段參加羽毛球及乒乓球等課外 活動。

日籍空姐染疫無源頭 北角健身房高危

基斯坦,其中5人爲新來港外傭。輸入個案中有7宗屬 N501Y變種病毒,令本港變種病毒個案增加至128宗。
