The property insurance of PT DATANG DSSP POWER INDONESIA and its subsidiaries is about to expire. Therefore, PT DATANG DSSP POWER INDONESIA intends to conduct procurement for Property Insurance. PT DATANG DSSP POWER INDONESIA hereby carries out an open tender for the procurement of Property Insurance. All companies that meet the qualification requirements as set out in this Announcement are welcome to participate.

- 1. Description:
- 1.1 保险财产地点:印度尼西亚境内,包括雅加达、中加里曼丹省、南 苏门答腊省、东南苏拉威西省。
- 1.1 Location of insured property: Indonesia, including Jakarta, Kalimantan Tengah, Sumatera Selatan, and Sulawesi Tenggara.

苏姆赛发电公司由2台150兆瓦(共300MW)的机组组成,位于南苏门答腊省 的MUSI BANYUASIN自治区的BAYUNG LENCIR,于2016年12月20日投产 运营;卡尔登发电公司由2台100兆瓦(共200MW)的机组组成,位于印度尼 西亚中加里曼丹省, Gunung Mas县, 于2020年11月4日投产运营; 肯达里 发电公司由2台50兆瓦(共100MW)的机组组成,位于印尼东南苏拉威西省纳 威南部, Tanjung Tiram, 于2019年 10月 28日投入商业运行。

印尼大唐金光电力有限公司是上述三家电厂的控股公司及管理单位。

1.2 General information:

PT DSSP POWER SUMSEL operates a power plant which consists of two units each with the capacity of 150 MW (total 300MW), and is located in Bayung Lencir, Musi Banyuasin regency, Sumatera Selatan province. The power plant was put into commercial operation on December 20, 2016; PT SKS LISTRIK KALIMANTAN operates a power plant which consists of two units each with the capacity of 100 MW (total 200MW), and is located in Gunung Mas regency, Central Kalimantan Province, Indonesia. The power plant was put into commercial operation on November 4, 2020; PT DSSP POWER KENDARI operates a power plant which consists of 2 units each with the capacity of 50 MW (total 100MW), located in Tanjung Tiram village, Konawe Selatan regency, Sulawesi Tenggara province. The power plant was put into commercial operation on October 28, 2019.

PT DATANG DSSP POWER INDONESIA is the holding company of the abovementioned entities being the subsidiaries operating the above three power plants.

本次招标工作范围包括2021-2022年度印尼大唐金光电力有限公司及其 所属单位苏姆赛发电公司、肯达里发电公司、卡尔登发电公司的财产一切 险、营业中断险-财产一切险项下、机器损坏险、营业中断险-机器损坏险项 下、商业综合责任险的保险保障。

The scope of the services procured under this open tender covers the 2021-2022 insurance coverage of Property All Risks Insurance (which shall include Business Interruption Insurance), Machinery Breakdown Insurance (which shall include Business Interruption Insurance), and Commercial General Liability Insurance for PT DATANG DSSP POWER INDONESIA and its subsidiaries(i.e. PT DSSP POWER SUMSEL, PT DSSP POWER KENDARI, and PT SKS LISTRIK KALIMANTAN).

3. Qualification Requirements for Bidders:

投标人应具有圆满履行保险合同的能力,具体应同时具备以下资格条件: Bidders shall have the capability to provide the insurance that meets the requirements successfully, and shall also specifically meet the following qualifications criteria.

- 3.1 The bidder shall be the Head Office of a qualified Indonesian insurer having a registered office in Indonesia as evidenced by the Company's Domicile Letter (Surat Keterangan Domisili Perusahaan), and shall have a valid Insurance Business License issued by Financial Services Administration(Otoritas Jasa Keuangan – OJK).

- 3.2 The bidder shall be the top 20 in Indonesia insurance market ranking by the 2020 premium income.

- 3.3 The bidder should be able to arrange the reinsurance for the insurance, where all the reinsurers should have credit ratings at least or better than A- by Standard & Poors/ Fitch or at least or better than A3 by Moody's.
